ADDITIONAL TERMS AND CONDITIONS

1. I am not an employee, agent or legal representative of Fusion-World (hereinafter FW), a division of San Giovanni Phil. Ind. Corp. (hereinafter SG). I am an independent contractor who agrees to be responsible for learning and complying with all applicable and relevant laws and to pay any taxes and other assessments required by national, state, municipal and local laws or other statutes and regulations. I understand that I can delegate obligations under the Contract to others, but that I am solely responsible for ensuring that anyone to whom I delegate any obligation complies with the contract.
2. I confirm that I will not use or appropriate to myself, directly or indirectly, the registered or unregistered trademarks, trade names and other proprietary marks of FW &/or SG. thereof ("Trademarks"), whether or not used in commerce, to promote its business opportunity or to register the said Trademarks as domain names without prior written approval from Fusion World. I agree that any unauthorized use of the Trademarks constitutes a material breach of this agreement and that all materials and products bearing the unauthorized Trademarks or domain names and any registration or application thereof shall automatically become the property of FW &/or SG and must be assigned unconditionally to San Giovanni Phil. Ind. Corp.
3. I agree that I will make no statements, representations claims, or warranties regarding FW/SG products which are not contained in official FW/SG promotional materials produced and distributed by FW of which are otherwise authorized by San Giovanni Phil. Ind. Corp. for distributorship in my country.
4. Neither my partner/spouse nor I have been party or participant to a FWCLM distributorship individually in a partnership, or as a shareholder, principal, officer or director of a company distributorship or other entity in the past six months.
5. If any provision of this Contract is found to be unenforceable or invalid, the validity of the remaining provisions shall not be affected.
6. In the event that I use any sales materials not produced by FW/SG, or otherwise approved for use by FW, I accept full responsibility for the information contained therein. I agree that my use of sales materials not conforming to the above requirements, to other applicable FW/SG Policies and Procedures, and to all local, provincial, territorial and national laws may result in the termination of my Contract and/or other appropriate disciplinary action.
7. I agree that when inviting prospective FW Distributors, I will fully disclose that the prospective distributor has no financial obligation other than purchasing the FWCLM Business Pack as a prerequisite to become a Distributor. I shall fully disclose the option to become a FW Distributor by purchasing a FWCLM Business Pack which does not contain any material or product on which bonuses are paid and must ask the prospective distributor to read the contract. I agree and understand that I am prohibited from charging, collecting, receiving or obligating a new distributor to pay more than the cost of Business Pack as stipulated.
8. I agree that I will make no specific earnings, representations or income guarantees, expressly or by implication, nor will I display actual photocopies of bonus checks or bonus statements in promotional materials, or business opportunity or any other method used to present the FWCLM & Compensation Plan to new prospects.
9. Only FW/SG products supplied exclusively by Fusion World may be sold in the countries where FW is present. I certify that I have not previously imported and will not import FW/SG products into my country. I hereby acknowledge that to do so would cause irreparable damage and harm to FW/SG for which Fusion World may terminate this Contract.
10. Fusion World may terminate this Contract at any time by giving me written notice if I am in breach of any of the provisions of the Contract. Otherwise this contract is a continuing and enforced contract.
11. Fusion World may amend the terms and conditions of the Contract at any time upon thirty (30) days written notice to me at my address appearing herein sent via registered post or facsimile, or posted on the Fusion World Website, Newsletter or Distributor Update or other official publication produced by Fusion World which are provided to Distributors. I agree that any such change or modification becomes effective thirty (30) days after notification and are automatically incorporated into the Contract as binding and enforceable provisions. I acknowledge acceptance of the new Contract terms by continuing to purchase Fusion World products after such changes or modifications have become effective.
12. I shall not convey, assign or otherwise transfer the Contract without prior written consent of Fusion World.
13. I will become an independent contractor and distributor of Fusion World and I will, at that time, have the right to sell FW/SG products (the "Products") in accordance with the FWCLM & Compensation Plan (the "Compensation Plan"). This Application will be deemed accepted by Fusion World when it is entered into the Fusion World database. If I submit this application by facsimile, I must sign both sides before the Application will be deemed received by Fusion World. Applications submitted by telephone will be temporarily accepted; however, the original application or a facsimile of both front & back, thereof must be received by Fusion World within thirty (30) days for it to be considered for acceptance.
14. I have read the Creative Leveraged Marketing & Compensation Plan as well as the Policies and Procedures for Fusion World Independent Distributors (the "Policies and Procedures"). I agree to abide by the terms and conditions of each of these documents, and I agree that the terms and conditions of the FWCLM & Compensation Plan and the Policies and Procedures including revisions, supplements, and amendments thereto be incorporated herein by this reference. This is an integrated Contract (the "Contract") that also includes the documents. No other promises, representations, guarantees, or agreements of any kind shall be valid unless in writing and signed between Fusion World and myself. I acknowledge that any violation of the Contract or any other agreements or obligations I may have with Fusion World or any of its affiliated entities may result in the termination of my membership or other disciplinary action as deemed appropriate by Fusion World.
15. I understand that no purchases are necessary to become a Distributor other than the purchase of a FWCLM Business Pack, which does not contain any commissionable product.
16. This Agreement allows me to sponsor prospective Distributors of Fusion World. I may sponsor Distributors in other countries pursuant to the conditions of the Fusion World Guidelines.
17. I understand and agree that my compensation from Fusion World is established by the FWCLM & Compensation Plan and will consist solely of commissions, rebates, overrides, and/or bonuses relating to the sale or other output derived from in-person sales, solicitations, or orders from ultimate consumers, in the home or otherwise, rather than in a permanent retail establishment.
18. I agree that I may not alter, repackage, re-label, or otherwise change any FW/SG Product, nor will I sell any such Product under any name or label than that authorized by Fusion World. I further agree that I will refrain from producing, selling and using (for the purpose of advertising, promoting, or describing the Company's products) any compensation plan, program, writing, recording, or any other materials that have not been previously approved or provided by Fusion World.
19. I certify the accuracy of all information provided by me in this Pre-Registration Form and agree that providing false or misleading information authorizes Fusion World, at its election, to declare this Agreement void from its inception.
20. I understand that only Distributors in good standing (such status is determined by Fusion World) may sponsor new Distributors. Fusion World, in its sole discretion, may reject this agreement without disclosing any reason thereof. If this Agreement/ application form is not accepted or approved, I release FW/SG and its officers, directors, agents, advisors, and employees from all liability incurred by me or by any other person. I waive any associated claim(s) that might be asserted in my interest.
21. I certify that I have read and understood the terms of the contract and agree to comply with them. I acknowledge that any violation of the terms of the contract may result in the termination of my Contract (Membership) or other disciplinary action as deemed appropriate by FW/SG.
22. I shall not engage in or involve myself and/or my spouse and/or relatives up to the 1st degree of consanguinity or affinity, directly or indirectly in any trade or business of similar nature or to be in conflict with the practice being carried out by Fusion World, unless I obtain prior consent in writing from Fusion World. This prohibition shall remain in effect within one (1) year from the termination or expiration of this contract.
23. I shall not engage or involve myself in any form of pyramiding via placement and positioning of sponsored downlines, direct or indirect, and I voluntarily consent and authorize Fusion World to suspend my account in the event that I engage in this prohibited act as mentioned in this specific provision.
24. I agree that SanGiovani makes no guarantee of any earnings or profits to any Distributor participating in the Fusion World CLM Compensation Plan. Any statement to the contrary is a misrepresentation. Successful results depend upon hard work, diligence and leadership.
